## FREED, but for HOW LONG?

TORONTO—A 62-year-old woman released from jail after 28 months for picketing a Toronto abortion clinic says she promised her mother she would stay out of trouble long enough to visit her in British Columbia. Linda Gibbons, a 62-year-old mother of three, has spent 10 of the past 17 years in jail.

But Linda Gibbons vowed to return to the front lines of anti-abortion protests even if it almost certainly means an immediate return to jail.

"I want to, God willing, go see my mom in July. I haven't seen her for three years," Ms. Gibbons said in an interview Sunday, her second full day of freedom. "I believe I would probably be back at the abortion clinics shortly thereafter."

Ms. Gibbons walked out of jail on Friday after Ontario Court Justice Mara Beth Greene granted her lawyer's application requesting that she be released without conditions. It was a surprising victory for the unrepentant protester, who has spent 10 years in jail and inspired her 89-year-old mother to write a poem about her legal travails. Amidst the Chile mining accident in 2010, her mother wrote: "It's easier to get miners out of a hole than to get Linda out of a gaol."

Over the past two decades, Ms. Gibbons has been arrested repeatedly for breaching a court injunction forbidding her from protesting outside several downtown Toronto abortion clinics. Each time she could have walked free on bail she refused to sign an order agreeing to obey the injunction, calling her decision a "principled" stand against compromising her beliefs.

"For me to sign off is to say that I will compromise my commitment to the unborn when it comes to legal restrictions," she said. "I'm not ready to toy with my commitment to pro-life. It would almost be like me telling the unborn, 'Sorry, I can't defend you this time.'"

Her most recent stint behind bars goes back to January 2009. Ms. Gibbons says the last 28 months were long, but that she compartmentalized her own problems to focus on counselling fellow inmates. "I'm either counselling the women on their addictions, or I'm counselling some woman not to have an abortion, sharing the faith with them or giving them some encouragement to get through the day," she says. "When you're in there, you're not saying, 'I wish I wasn't here.' You're just saying, 'What do I do here?'"

In granting her release, the judge ordered Ms. Gibbons to return to court on Jan. 16, 2012 to face a charge of disobeying a court order that goes back to October 2008. The Crown has said that if Ms. Gibbons does not stay away from abortion clinics she would be re-arrested and charged, says her lawyer Daniel Santoro. But Ms. Gibbons insists she is not doing anything criminal.

"I'm there to defend my beliefs, but also to defend the Christian heritage of this country, that we are a country where we have freedom of expression, whether it be a religious or a value system."

Since Aug. 30, 1994, when a civil court placed a temporary injunction around several abortion clinics in downtown To-

ronto at the request of the provincial Attorney-General, Ms. Gibbons has been arrested 20 times for various offences under the Criminal Code.

Mr. Santoro has argued that the case should never have been prosecuted criminally, but should have been sent back to civil court.

This winter, the Supreme Court of Canada agreed to hear Ms. Gibbons' case. Mr. Santoro will argue a heavy-handed Crown used the Criminal Code to punish Ms. Gibbons beyond the severity of her offences.

The injunction was initially issued during a climate of great antagonism between those on both sides of the abortion issue. It was only six years earlier that the Supreme Court of Canada struck down the country's abortion law, making Canada the only Western country to have no rules and regulations on abortion.

"I have really said in my mind that as long as the injunctions exist and God gives me the ability to stand on my feet, that I will continue to challenge these injunctions as long as they exist," Ms. Gibbons said.

The banner you see in the picture will never be seen again as this Spring K-W Right to Life was clearly discriminated against by City of Waterloo officials. Correspondence with Public Works began last Fall regarding placing our banner across King St. Officials were to come up with “prohibitions” for who and who would not be allowed to purchase banner space. After K-W RTL received the “prohibitions” we pointed out to Public Works that there was apparent discrimination in several of the points. Most just didn’t make any sense at all.

This prompted Public works to discon-

tinue the service of overhead banners due to the faulty poles, a convenient excuse to avoid controversy. We explained to City of Waterloo Council that putting an end to purchasing overhead banners is not a big issue, however discrimination is.

The issue is now mute. In one way we won the issue. The attempt to deny us banner space did not work. The City of Waterloo was publicly discredited through a Waterloo media source. A letter that was printed in the RECORD describing the events that took place to the demise of all overhead banners for 40 businesses and non-profits.

### Re: Charity banners come down in Waterloo — March 22

K-W Right to Life has purchased overhead banner space from the City of Waterloo public works for over 15 years. Like more than 30 other charities, we were disappointed about the cancellation of banners in 2011 due to the structural integrity of the poles. Banners provide needed affordable awareness for events that support non-profit organizations.

Last September K-W Right to Life’s application for banner space was promised no commitment for 2011. Since that time public works staff began reviewing the various aspects of providing the service and determined that changes regarding who would and would not be allowed to purchase banner space be applied to the new policy.

Discontinuing the service to purchase overhead banner space due to the poles ignores a significant issue. It is my opinion the integrity of the decision-making process for a banner policy was compromised based on belief systems. This may have resulted in denying K-W Right to Life and other charities the availability of purchasing future banner space. Mandates of any charitable organization will always infringe on someone else’s opinion. Tolerance bears this realization and helps build up communities.

The City of Waterloo should have maintained the valuable tradition of allowing registered charities the availability to purchase banner space for their events. All charities that follow the Policy Statement of Canadian Charities should be given equal opportunity by the City of Waterloo.

# The Ontario School Battle

## **A Legal expert on Catholic school rights in Ontario scolds weak-kneed attitude of submission and surrender to Premier McGuinty's Equality and Exclusiveness Policy.**

**LifeSiteNews of Friday, May 20, 2011, reported that:**

"A detailed legal opinion was delivered Thursday, May 19, to the Assembly of Catholic Bishops of Ontario and trustees of the Toronto Catholic school board regarding the controversial government equity program. The opinion shows, with legal documentation and precedents, that the bishops and other leaders in Catholic education have the legal capability and right to reject the Ontario Government's imposition of homosexual clubs in Catholic schools.

It continues: "Mississauga lawyer Geoff Cauchi firstly cites Vatican documents issued by now-Pope-then-Cardinal Joseph Ratzinger exhorting bishops that a truly caring approach to those who are homosexually inclined must clearly state that homosexual activity is immoral. Such an approach to gay clubs in Catholics schools has been expressly forbidden by the Ontario Ministry of Education.

"Cauchi explains that the leadership in Catholic education has "constitutional denominational rights recognized by the Constitutional Act, 1867 to refuse to comply with what he notes are the Ontario Governments unlawful and unconstitutional demands. In his legal opinion, Cauchi asserts that based on the text of section 93 of the Constitution Act, 1867 and a fair reading of the case law interpreting it there would not only be one but three



legal methods to oppose the Government's attempt to force gay clubs in Catholic schools.

"In urging the Catholic leadership to undertake such action, Cauchi notes not only the Vatican imperative cited above but also medical evidence. He points out the lack of credible empirical sociological evidence that the Church's teaching on homosexuality induces some students to unjustly discriminate against other students who think they have a same-sex attraction. 'The absence of any such evidence by and of itself destroys the case for anti-bullying strategies that contradict the fundamental contents of faith and morals, as taught by the Catholic Church,' he writes...."

# Planned Parent-Hood – Still Racist Today?

Last week, Planned Parent-hood founder Margaret Sanger was examined for evidence of a racist and eugenic agenda in her early work, and was caught red-handed. Her colleagues had ties with the Third Reich, and spoke publicly about the “Jew Problem” and the “black peril.” (Knopf, 1925.) She herself called black aborigines “just a step higher than the chimpanzee.” (What Every Girl Should Know, 1920.)

However, when issues about the history of Planned Parent-hood and its founder come up, two common criticisms are: “Just because she was racist then, doesn’t mean Planned Parent-hood is racist now. They even had an African American president, Faye Wattleton!”

“Planned Parent-hood is mostly about birth control; they existed decades before abortion was even legal.”

Ironically, that’s exactly the point of this article. Planned Parent-hood is about birth control; it was born out of a eugenic movement that recommended sterilization and segregation as its primary birth control tools. And immediately after sterilization and segregation legally failed, abortion appeared on the scene, and minorities were targeted for abortion just as heavily as they were targeted before for sterilization and segregation. The sad truth: abortion became a far more effective and lucrative eugenic tactic than anything that came before it. More sadly still, the eugenic movement seduced black leadership by rebranding eugenic birth control as a civil right, and that’s exactly how an African American woman could end up as president of a still-racist organization.

## The Seduction of Black Leadership and the Founding of the Negro Project

In 1939, Sanger retooled the Birth Control League to become the Birth Control Federation of America. Under this new name, Sanger’s first goal was called the “The Negro Project,” intended to persuade black women to stop having children.

Dr. Clarence Gamble (of Proctor and Gamble fame) who had served as director of the Birth Control League and was appointed as the regional director of the South, sent Sanger a memo entitled “Suggestion for Negro Project,” where he warned that black leaders would likely see her strategy as a plot to exterminate the blacks. His solution? Enlist carefully selected black leaders to spread the word instead. They’d take the pill if it were from their own people and no one would suspect a thing!\*
