## Politics and Motion 312 and Conservative MP Stephen Woodworth

Ground breaking possibilities have been presented to us by an MP who has done more for the prolife movement than anyone in the last 40 years or so.

Stephen Woodworth's present motion 312 represents a brilliantly pure effort to change abortion in Canada whether or not it is successful in passing.

Even prolife skeptics should concede that it is not "just another motion". Faulty politics and unrealistic expectations can lead some groups to hold back from the fundamental course for change that must begin with the repudiation of law 223(1).

This may explain why it has taken over 24 years to successfully counter abortion on demand in Canada. All other efforts pale and promise less success in relation to when life begins and ends than the issue of established personhood for the preborn.

By the passing of Motion 312, best results can change the landscape of abortion in Canada by granting personhood to hundreds of thousands preborn babies.

It would also provide a base for successful amendments to the criminal code around protection of life issues i.e. informed consent, sex selection, conscience clauses etc.

A united effort to market this prolife message across Canada could increase chances of success exponentially.

Results by Motion 312 not passing can drive discussion toward legislators' abuse of power through an archaic law in which modern society refuses to question its validity.

New generations are seeing truisms more clearly than those from the past who out of fear and ignorance fell for a mistaken belief of abortion as a means to personal autonomy.

## 40th Anniversary of Kitchener-Waterloo Right to Life Association

I am grateful to Jane Richard and to the Board of RTL for planning this 40th Anniversary Celebration of K-W & Area RTL Association, and what a delight it is to see so many here tonight.

Just a little bit of history: In 1971 Hart and I happened to see a TV programme called THE BEAR PIT, where Grace Hargreaves of Toronto Right to Life was speaking for the pro-life cause. It seemed to be a hostile group, but we were impressed by Grace's calm and well reasoned rebuttals. At the end of the program it was announced that a prolife march from NATHAN PHILIPS Sq. to the St. Lawrence Centre of the Performing Arts would take place on a certain date and the guest speakers would be Dr. & Mrs. Jack Willke of Cincinnati, Ohio. We decided to attend, I was about 7 months pregnant at the time. The Willkes showed slides, and also had for sale their book, Handbook on Abortion, We bought the slides and the book.

We shared this information with our friends, John and Judy Vanderkooy who attended the Christian Reformed Church on Ottawa St. Kit. They arranged for a showing at their church and the response was very gratifying. In fact they put their convictions to the test and gave us some money for a newspaper advertisement. It was through that ad that Madeline Gaboury and several others made contact with us. I believe that Norene O'Connor allowed her phone number and address to be the contact for anyone wanting to get in touch with RTL. What was in the air at the time was a movement to get all mention of abortion out of the criminal code. On January 12, 1972, six of us gathered to prepare for a public meeting with speakers Dr. & Mrs. Jack Willke at Waterloo Lutheran University, on February 26.

At this time we decided to form a steering committee, and to take the

Kitchener-Waterloo Right name Life Committee. Responsibilities were distributed as follows: Chairman: Madeline Gaboury, Treasurer: Judy Relations: Vanderkooy, Public Janie Rusticus, Director of Information Dr. Hart Bezner, Ministerial Advisor: Rev. Ralph Humphries. About 150 people came to that meeting. The Willkes showed a film of an actual abortion, and I remember that one man fainted.

The next public meeting was held April 12th at Kitchener Public Library, to hear Dr. Barry De Veber, a noted Paediatrician at Victoria Hospital, London. Around 50 people attended. After this meeting the committee decided that it was not our purpose to hold public meetings, but rather to provide speakers with slides, and films and literature to interested groups, and that proved to be very effective.

That spring we used the gazebo at Fairview Mall to set up a display and give out literature. Several members helped to staff the booth and enjoyed the opportunity to talk with the public. On the basis of that good experience we decided to rent a booth at the COE, Aug 29-Sept 4. 34 volunteers staffed the booth, and again, public response was most encouraging. 1,000 copies of Speak Up for Life were given out plus many other articles. 750 signatures were obtained on the petition to be presented to the federal government.

About petitions - we presented the largest petition ever to the federal government. I think it carried about 475,000 signatures. The word that came back was, that is not enough, bring back 1,000,000. The government's response to the 1,000,000, in 1975, was the Badgeley Commission to ascertain if the abortion law was being applied equitably across Canada. This was such a downer. I would say that the 1970's was a time of ferment politically and socially - the feminist movement women's rights, the Vietnam war, student unrest. All of us were caught up in this, whether we realized it or not. Henry Morgentaler opened an abortion clinic

in Montreal, and on one Mother's Day we were treated to watching Henry M. perform an abortion on CBC. It was also a time of the presenting of briefs by RTL to the Ontario government, to the medical board at K-W Hospital, and to the news media.

Speaking engagements were many. It was such a privilege to share with students and adults how the unborn child develops and what an abortion does. When we spoke in schools, we told students what they would be seeing, (the journey that each of them had taken) and made it clear that they didn't have to watch, but with the reminder that these slides would act as a reality check. We cannot make an informed decision without all the facts. The picture, What about his rights? and the Tree of Life pin are symbols that speak volumes. We also had available the specimens of a 12 week old baby and a 18 week old, noting the rapid growth that takes place in just 6 weeks to awaken in each one a sense of wonder and awe.

RTL is all about education; getting out the facts, whether it is the statistic about the development of the unborn child, abortions done province by province, in our hospital, post abortion stress, child abuse, the importance of language (liberal law-permissive law), respecting life, loving life, a culture of optimism rather than despair. A lot of information was being gathered and we began to realize that an office centrally located would be a very good thing.

The office was opened at 91 Frederick St. Kit. September 1977 by the Hon. Perrin Beatty, Wellington-Grey-Dufferin-Waterloo. Perrin was also bringing forth his own private member's bill asking that "health" be removed from the law on abortion. I believe that our first office coordinator was Wynn Eastman, followed by Pam Dlugokechi, Pat Schiebel and then Barb Davie. After offices on Scott St., Victoria St. S. then King St. N., Jane Richard, now houses the office on Lancaster St. W.

I would like to give a huge thanks to Pat Macauley who ordered and stored all the literature in her home in those early days, and to Doreen Schaeffer who looked after the Membership Drive from her home and to Helen Bastien who stuffed the newsletter envelopes with a company of volunteers in her home, and fed them her wonderful onion sandwiches.

It gives me much pleasure to honour our presidents, Madeline Gaboury, Pat Partington, Mary Bruder, Bernard Currie, Kathy Morrison Lance, Roseanne Sheridan, and Jane Richard. With each President there was also an executive, so our thanks go out to those individuals who gave much.

I can see the faces of many volunteers in my mind, some of them are no longer with us, some can't be here because of infirmities, but you are here. I give thanks for each one, because I believe that each of us has made a contribution to the protection of human life.

I SHOULD ALSO EXPRESS MY DEEPEST APPRECIATION TO BIRTHRIGHT whose volunteers have given a loving form to the respect for life ethic.

Let me go back to the paragraph we had on our membership form

In a free society the life of an innocent human is simply not up for discussion, no matter how tiny or how defenceless, and the deliberate killing of the

innocent has always been regarded as the basest of acts. It is not sufficient to turn aside and wish to have no part in it.

# Views misrepresented June 28, 2012 The Record

Re: A woman's decision — June 21

One challenge of public debate is that opponents can misrepresent your views.

I must respond to Helen Hansen's recent letter.

Motion 312 does not restrict a woman's access to early abortion on demand, as Hansen suggests.

It proposes no more than a review of evidence about whether or not a child is a human being before the moment of complete birth. Does Hansen suggest that a woman's access to abortion depends upon the pretence that a child is not a human being before complete birth if the evidence establishes otherwise?

Motion 312 is not about "when an embryo is a person," as Hansen suggests. It is about the decree in subsection 223(1) that a child is not a human being until the moment of complete birth. Very few Canadians doubt that a child in the final weeks of gestation, with perfectly formed organs and limbs, is a human being.

Motion 312 is about whether Canadians will tolerate a law giving governments the right to strip any human being of human rights, contrary to the principle

that human rights are universal and inherent, not subject to cancellation by a decree like subsection 223(1).

Motion 312 is about the need to reconcile differing views through informed dialogue.

Should a 400-year-old definition of human being be frozen in time forever because of the int ransigent refusal of a few to consider modern evidence?

The title of the article written by Paul Ranalli, a Toronto family doctor, was "Abortion law unlikely without change in tactics". The sub-heading reads: Allor-nothing approach by some pro-lifers to force policy against 'choice' hasn't worked.

So, here is the substance of the article. Alliance for Life's goal is legislated protection of life for every Canadian citizen in or out of the womb. All OR NOTHING. And which one of us in any pro-life group would oppose that goal, probably not one. The problem lies in the getting there.

The article goes on to give many examples from Mahatma Ghandi to Martin Luther King how the incremental strides were the key to success. Ghandi's step was to go to the coast to make salt without paying the salt tax to the British or the incremental step of a black person sitting anywhere on the bus. History is full of these first steps, their participants thinking that so far they had accomplished nothing, just as Motion 312 would accomplish, maybe nothing, maybe everything.

Criticism of the process that is making its way to the media, and to the legislature cannot be tolerated. Any move towards our goal is good. If the tables were turned, and a bill was up for discussion on ending all abortion in Canada, would all of us, though it would not be realistic to expect success, not support it with all we had. We need to support every non-violent stride by any pro-life group or member of parliament to move forward in any way, on any means of education or law. Motion 312 should not be undermined or minimized by one of our own.




### A unique approach to ending abortion






